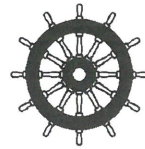

RIME shall maintain its recognition by the Japanese Government as a recognized test laboratory and shall maintain listed on the SSE.1/Circ.3 published periodically by the International Maritime Organization.

RIME shall inform Nippon Kaiji Kyokai (Netherlands) B.V. when one or both of the above conditions is suspended or withdrawn.

Note:

This attestation does not indicate that the tests carried out by RIME shall be accepted by other Notified Body's certifying equipment covered by the MED 2014/90/EU Directive.

Nippon Kaiji Kyokai (Netherlands) B.V. hereinafter NKK(NL)BV shall be timely approached by the manufacturer intending to use RIME for type examination tests, allowing NKK(NL)BV to decide if the required tests may be carried out by RIME independently, or have to be conducted or partially conducted by an inspector employed or contracted by NKK(NL)BV.
